### **Objectives of the Course:**

This course aims to introduce students to the main institutions of the European Union, as well as to the politics and governance of the Union. It will provide an overview of the main EU institutions, focusing principally on the decision-making triangle of the EU and the interactions that take place between these institutions in the law making process. The different decision-making procedures - and the co-decision procedure in particular - will thus be assessed through the scrutiny of the decision-making process, from agenda-setting to implementation. Moreover, the management of the EMU and the Euro-zone will also be examined by studying the main economic and monetary EU institution, the European Central Bank. The European election process will also be observed, as questions of democratic legitimacy are addressed. The notion of Euroscepticism will be explained and the democratic deficit problem will further be assessed. From this perspective, the Treaty establishing a Constitution for Europe will be looked at, by considering its main provisions and its likely impact on the EU's system of governance. The reasons for its failure will thus be identified and the Reform Treaty will be discussed, by looking at its main institutional and policy changes. Succinctly, the evolution of the Union's institutional governance system, from establishment of the Community to the set-up of the three-pillar structure under the Maastricht Treaty to the adoption of a legal personality under Lisbon, will thus be appreciated in this context.

### **Learning Outcomes:**

After completion of the course students are expected to be able to:

1. Illustrate an understanding of the EU's system of governance.
2. Demonstrate knowledge of the division of the Union's competences into the Three-Pillar Structure under the Treaty on European Union and assess the capabilities and the capability gaps of the organisation in each of these three pillars.
3. Report on the European Commission and the Council of the European Union, explaining the functioning of the EU's institutional arrangement, and evaluating it in terms of institutional balance.
4. Discuss how the European Parliament is composed and how it works, and appreciate the importance of European Election.
5. Assess the importance of the European Central Bank in the functioning of the Economic and Monetary Union of the EU, and also look at other EU Bodies.

6. Evaluate and assess the process of decision-making in the EU from agenda-setting to implementation.
7. Assess the failure of the Treaty establishing a Constitution for Europe, by considering its main provisions and its likely impact on the EU's system of governance.
8. Appraise the main institutional and policy changes under the Treaty of Lisbon and appreciate the significance of the EU as a legal personality.
9. Demonstrate substantial knowledge of the concept of Democracy in relation to the EU and the Euroscepticism that surrounds it, assessing its democratic deficit today.
