Objectives of the Course:

To deepen understanding of the practical working of the legal system by assessing the procedure of the Supreme Court and its subordinate courts, and the inner workings of the civil and criminal trial.

3. Explain the power of the District Courts

5. Discuss the inner workings of the criminal trial process
6. Demonstrate a broad understanding of the civil justice system
7. Explain the appeals system and understand its pivotal role in overseeing the lower courts and ensuring consistency in the development of the law
8. Illustrate how to take initiative, to undertake independent learning and develop powers of enquiry and critical analysis

4. The Power of the District Courts, Composition and Powers, Writ of Summons, An Introduction to Civil Procedure, Interim Orders
5. Composition and Powers of the Assize Courts, Prosecution and criminal trial, Classification of Offences, Sentencing, Bail
6. The Appeals system- Prerogative Orders
