Objectives of the Course:

The main objectives of the course are to:

- To develop knowledge and skills in caring for children and adolescents and their families in a hospital setting.
- To focus on children with more complexes needs disabilities and mental health issues.
- To explore contemporary issues in caring for children with complex health needs.

- Explore the rights of the child and family, and the advocacy role of the nurse.

Course Contents:

- Caring Skills: Children and adolescent health needs and caring needs. Assessment of the child and family on admission. Nursing interventions for the child undergoing surgery. CPR theory and practice. Nursing management of childhood infections; response to illness. Accident prevention. Drug administration
- Communication: Application of Humanistic Perspectives when communicating with children and their families. Conscious and unconscious aspect of communication
- Health Studies: Health education Theories and models related to children and families. Play, its relevance to childhood development and therapeutic play. A child's understanding of health and illness.
- Psychosocial Perspectives: Why sociology for children's nursing/Sociology and the experience of illness. Attachment theory and psychological development; Piaget and Koglberg.

Professional Practice: Ethical theory applied to the care of children. Rights and duties; the law and the child. Autonomy, competence and consent relating to children
