Objectives of the Course:

The course explores the relationship between terrorism and the nature of the international political system and looks at why an international dimension is so central to terrorism. First, it examines the difficulties in the way of understanding the concept of terrorism in the light of the emotive force of the term and the attempts by academics to distinguish terrorism from other forms of violence. Also, it examines the different strands of political violence in the 21st century. Finally, it examines the issue of stopping terrorism: case studies are employed to analyze factors that have influenced the ending or the extending of campaigns of violence.

Learning Outcomes:

After completion of the course students are expected to be able to:

1. Analyze and evaluate particular aspects of the Greek-Turkish relations.
2. Demonstrate independent research skills on historical, political, diplomatic and strategic issues which are pertinent to Greek-Turkish relations.
3. Illustrate mastery of a range of primary and secondary resources.
4. Illustrate an enhanced understanding of the impact of the Cyprus problem on the evolution of Greek-Turkish relations.
5. Integrate historical episodes of the Greek-Turkish relationship from the wider global perspective.
6. Examine the role of third parties in the development of their bilateral relationship.
7. Analyze the impact of the EU.
8. Illustrate a full understanding of the various dimensions of Greek-Turkish disputes and consider possible solutions.
