The main objectives of this course are to:

- Provide an integrated introduction to English legal system and method
- Have students engage with legal method, including legal analysis and legal research and writing
- Provide students with an overview of civil and criminal procedure
- Have students critically assess alternative dispute resolution systems
- Provide a thematic understanding of civil and criminal procedure and the purposes underlying such procedures
