## **Course Objectives:**

The course objectives are to:

To analyse and discuss the elements of the offences: Homicide, Non-fatal offences against the person, Sexual offences, Offences under the Theft Acts, Fraud, and Criminal Damage. Every chapter will also analyse the crimes' defences and excuses in conjunction with relevant case law. The course also aims to familiarize students with complex cases that combine different offences and parties to the crime.

## **Learning Outcomes:**

After completion of the course, students are expected to be able to:

- 1. Distinguish between murder and homicide and apply defences and excuses
- 2. Differentiate between fatal and non-fatal offences against the person
- 3. Comprehend and analyse differences among sexual offences and differentiate between sexual offences against adults and children
- 4. Understand in-depth the Fraud Act and be able to apply the current case law tests
- 5. Differentiate between theft offences and theft-related offences, and comprehend the notion of aggravation in certain offences such as burglary while differentiating to robbery.
