Objectives of the Course:

The main objectives of the course are to develop into students the theory and practice of administrative law, examine the criteria for administrative review under Art. 146 of the Constitution, including the 75 day rule, the legitimate interest for filing a recourse, the administrative act and the concept of a public authority. Introduce the case-law concerning administrative review.

Learning Outcomes:

After completion of the course students are expected to be able to:

1. Explain the nature and scope of administrative law and the function of the Supreme Court
2. Appraise the concepts of administrative act and public authorities
3. Assess the rules governing the principle of legality
4. Evaluate the application of the 75 day rule
5. Demonstrate the relation between art. 146 and art. 29
6. Discuss the rules and procedures governing judicial review of administrative action
7. Explain the structure of the administrative trial
8. Appraise whether factual circumstances are sufficiently elucidated for a legal decision
