Course Objectives:

The main objectives of the course are:

- To provide students with essential theoretical knowledge in the sub-field of political sociology, and assess its relevance and main topics.
- To specifically illustrate to students how such topics as gender, immigration and new technologies are studied in the realm of politics and international relations.
- To equip students with the tools necessary to examine how society evolves and changes over time, including in technological, demographic and political terms.
- The study and analysis of specific contemporary cases in the Eastern Mediterranean.

- To apply these concepts through empirical discussion of the interconnections between social and political forces.
- To illustrate the relevance of society and social phenomena for political conflict.

- To be able to discuss recent digital innovations and their effects on society and democracy, as well as matters of practical education among diversified social fields.
- To demonstrate substantial knowledge regarding the specific cases that were analysed in the later part of the course and to be able to explain their particular characteristics and their impact and consequences, in conjunction with the theoretical knowledge that they will receive in the first part of the course.
