## Course Objectives:

The course aims at providing students of International Relations with specialised knowledge about the relations between the EU and the South-Eastern Mediterranean, effectively offering them the opportunity to empirically apply theoretical knowledge. The course will apply tools, concepts and theories of international relations to the domain of area studies and with reference to recent events and puzzles in an area receiving increasing attention. By examining EU-South Eastern Mediterranean relations and inter-connections, the aim of the course lies largely at the provision of both a deeper knowledge about the South-Eastern Mediterranean and an introduction to dialogue between international relations and European Studies. The objectives of the course address all aspects of the EU-South-Eastern Mediterranean nexus, including the EU's foreign policy, the intervening role of other big powers such as Russia and the USA, social and cultural issues, the domestic politics of the EU's Eastern Mediterranean member states and recently arising challenges such as economic crisis, immigration, military conflict and debates around the flow of gas into the EU.

# Learning Outcomes:

After completion of the course students are expected to be able:

- To understand the significance of EU-Eastern Mediterranean relations for contemporary affairs and developments in both the Eastern Mediterranean and the wider EU.
- To assess the strategy crafted by EU elites in terms of its Eastern Mediterranean region.



- To be familiar with policy debates in the Eastern Mediterranean, pertaining to a variety of social, economic, military and other issues.
- To exhibit knowledge about the domestic politics of Greece and Cyprus, including their trajectories within the EU.
- To critically discuss the role of big powers and the nature of competition over hegemony in the Eastern Mediterranean.
