

INTRODUCTION BY THE DEAN, PROF. ACHILLES C. EMILIANIDES



Recent decades have seen a continuous discussion about the challenges posed to legal studies by technological innovation, new research methods, and interdisciplinary. The recent pandemic has abruptly led legal studies to a new era, which had been discussed for a long time: online teaching, increased usage of podcasts and online material as teaching methods, a globalized environment. Law is a unique academic field of study. The methodology, objectives, and teaching methods of legal studies differ from the standard respective notions of sciences and social sciences in university curricula and research, and have mostly led legal studies to be considered as an isolated, albeit extremely important, field. Law remains closely connected with the legal profession, and often views itself as a professional field, more so than an academic one. Whereas, most other disciplines have introduced collaborative works as the norm, legal academics still mostly view themselves as isolated researchers, who do not embrace the 'lab' or 'group' mentality, and who are skeptical of multi-authored publications. In most jurisdictions, the sole author monograph remains the 'golden rule' for promotion, whereas collaborative or joint publications are discouraged. Even the joint publication of PhD students with their supervisors, which is the norm in most other disciplines, is still viewed as an exception, with the PhD student aiming to complete a single authored monograph. Legal research and education remains predominantly national in nature, and individualised, whereas most other disciplines have grown to be globalised and depend on collectivity. In an era of technological advancement, most law texts remain, in spite of recent progress, hard to find, and expensive.

Despite criticism, however, there is little doubt that law is one of the fields that deeply affects the lives of people, and is a pillar for the organisation of societies. It is a highly complex field, with dozens of specialisations, and connection with most other scientific fields. Hence, law remains one of the most important disciplines in a university. The question of how legal studies can become more relevant to a modern society, however, remains a topical one, and the lessons learnt during the pandemic can help towards addressing these concerns in a post-Covid world.

The experience of the pandemic has shown that there are significant difficulties in opting for the online delivery of undergraduate law courses, together with alternative methods of assessment, and immediately adopting it as a norm in a post-pandemic environment would not be a credible option. However, the option of providing blended (hybrid) education might seem like an attractive solution in a post-pandemic society. The use of technology could improve the delivery of education and move away from the traditional techniques of legal education towards a more collaborative, societally relevant, and student-friendly pedagogical environment. Engaging the students with audiovisual and online legal material could enhance the student experience, in a manner appropriately directed towards a new generation of technologically advanced students. Legal education during the pandemic has shown that engaging the intellect of students and developing their critical thinking and scepticism, as conditions of legal education, can also occur in an online environment, albeit not exclusively. Quality could be served by introducing a number of new teaching and learning methods used successfully in other disciplines.

HIGHLIGHTS

Graduation Ceremony 2020/2021

On 28 June 2021, the School of Law held its Graduation Ceremony for both the academic years 2019-2020 and 2020-2021. This was the first time that the School held a distinct Graduation Ceremony, instead of participating in an all-encompassing University one. It was also the first time that the Ceremony referred to two graduating classes, since the pandemic had necessitated the postponement of the 2020 Graduation Ceremony. The Rector of the University of Nicosia, Professor Philippos Pouyioutas, highlighted the international ranking position of the University, which (at that time) was in the top 1000 universities in the world by the Times Higher Education World University Rankings 2021 (THE WUR 2021), and currently in the top 601-800 position (THE WUR 2022). Addressing the graduates of the School, the Rector expressed the wish that they confront the challenges that society currently faces, and that they further specialise in their respective fields. The Dean of the School Prof. Emilianides, noted that we live in an era of liberalisation and unprecedented technological change and we need to be as open-minded and innovative as possible, in order to effectively address the challenges and opportunities these developments present. The guest of honour of the ceremony, Law Commissioner Louiza Christodoulidou—Zannetou, called on the graduates to help create the state for which our ancestors gave their lives by redefining our collective objectives. She further called the graduates to serve the community, and to remain humble and humane, whereas at the same time always aim higher.





Re-Election of HoDs

Prof. Andreas Theophanous and Dr Christos Papastylianos were re-elected as HoDs for the Department of Politics and Governance, and the Department of Law, respectively. Dr Constantinos Adamides was re-elected as Associate Head of the Department of Politics and Governance, whereas Prof. Irene Stamatoudi was elected as Associate Head of the Department of Law.









Conference on Commonwealth and Cyprus

On 20-21 May 2021, the School of Law of the University of Nicosia, in collaboration with the Institute of Commonwealth Studies of the University of London, and supported by the Royal Commonwealth Society Cyprus Branch, organised an international scientific conference on 'Cyprus and the Commonwealth (1961-2021)'. The Conference marked the 60th anniversary of Cyprus' accession to the Commonwealth, and celebrated the recent cooperation agreement signed between the School of Law and the Institute of Commonwealth Studies. The Secretary-General of the Commonwealth Patricia Scotland, addressed the opening ceremony and highlighted the importance of Cyprus' continuous presence and engagement with the Commonwealth. Dean Emilianides, and Prof. Philp Murphy, Director of the Institute of Commonwealth Studies, provided a comprehensive overview of Cyprus' long history with the institutions of the Commonwealth. Deputy High Commissioner of the United Kingdom in Cyprus Ben Rawlings, also addressed the Conference, discussing the interplay between Commonwealth values and modern Cyprus. School Faculty Dean Emilianides, HoD Andreas Theophanous, Prof. Hubert Faustmann, Dimitrios Kourtis, Andreas Karyos, Marinos Papaioakeim, and Katerina Elia, presented papers during the Conference.



MoUs with the Ministry of Justice, and the Law Commissioner

In February 2021 Dean Emilianides signed MoUs with both the Office of the Law Commissioner, and the Ministry of Justice and Public Order. Pursuant to both MoUs the School of Law has undertaken to provide expert technical support during the preparation of draft legislation.





Faculty Promotions and Tenure

First Annual Book Awards of The Cyprus Review

The leading Cyprological social sciences journal The Cyprus Review, which is published under the auspices of the School of Law, held on 7 June 2021, an online award ceremony for its First Annual Book Awards. The categories included Law, History and Political Science, and Social Sciences, as well as a Lifetime Achievement Award, and referred to books published in 2019. The Stanley Kyriakides Award on History and Political Science was conferred to Dr Charis Alexandrou, whereas the Junior Researcher Award was jointly conferred to Dr Marilena Varnava and Michalis Stavri. The Constantinos Emilianides Award in Law was conferred to former Supreme Court Judge Frixos Nicolaides, whereas the Junior Research Award in Law was conferred to Dr Anastasia-Maria loannidi. Nicos Panayiotou received an honourable mention. The Lifetime Achievement Award was conferred to Prof. Evanthis Hatzivasiliou for his long-standing contribution to the development of Cyprological research. Prof. Hatzivasiliou delivered a keynote address in the event, on the trends of modern Cyprological historiography. The Editor-in-Chief of The Cyprus Review and Associate Dean of the School of Law, Dr Christina loannou, gave an introductory speech and chaired the ceremony.





Phedon Nicolaides Joins the School

Phedon Nicolaides, a Professor at the University of Maastricht, and Visiting Professor at the College of Europe and LUISS University in Rome, joined the School as a Professor at the Department of Law. Phedon is especially renowned for his work in state aid law, and European economic governance, and has previously served as Minister Plenipotentiary in the Cyprus Ministry of Foreign Affairs. He has published extensively on European integration, competition policy and state aid, and policy implementation. He is also on the editorial boards of several journals.

Third Saripolos Lecture

On 25 November 2021, the School of Law co-organised the prestigious Saripolos Lecture, with the Larnaca Bar Association under the auspices of the Municipality of Larnaca, hometown of prominent jurist Nikolaos I. Saripolos. The Lecture was delivered by Prof. Panagiotis Delimatsis (Tilbug), who addressed the future of the Common European Commercial Policy from the Legal Viewpoint. Prof. Irene Stamatoudi chaired the event, whereas Adjunct Faculty Dr Nicolas Kyriakides and Criton Dionysiou made brief interventions. The Mayor of Larnaca Andreas Vyras, the President of the Larnaca Bar Association Christakis Mouskos, and Dean Emilianides, addressed the event.



Public Administration Review

In November 2021, the School of Law of the University of Nicosia published the first issue of its new peer-reviewed e-journal on Public Administration, named Public Administration Review (Επιθεώρηση Δημόσιας Διοίκησης). The Journal will be published bi-annually in the Greek language and will host high-quality academic contributions, thus fostering interdisciplinary scholarship and excellence. Dr Giorgos Kentas is the Editor-in-Chief, whereas the Editorial Team also comprises Dr Ioannis Rossides, Dr Giorgos Tsaousis, and Dr Ioannis Kastanas.





Distinguished New Adjunct Faculty Joins the School

Former President of the Supreme Court Myron Nicolatos, former Chief of Police Zacharias Chrysostomou, and former President of the Military Tribunal Philippos Patsalides, joined the Department of Law of the School as Adjunct Faculty. Other faculty additions in 2021 included practicing criminal lawyer Antonis Baltas, and former top executive in the banking sector Bill Gallagher. The new faculty are part of the School's ongoing effort to ensure interaction between theory and practice, and equip its students with skills that will prove useful to them in the labour marker.

MoU With the Research Institute for Transparency, Corruption and Financial Crime of AUTH

In October 2021, Dean Emilianides signed an MoU with the Research Institute for Transparency, Corruption and Financial Crime of AUTH, represented by its Director Prof. Maria Kaiafa-Gbandi, and the Dean of the School of Law of AUTH Prof. Panagiotis Glavinis. The MoU fosters cooperation between the two institutions and supports their joint action in research projects, academic conferences, and specialised seminars.



Journal of the Sociology of Law and Religion

In November 2021, the School of Law of the University of Nicosia, in cooperation with the PhD Programme on Human Rights, Society, and Multi-Level Governance offered by the Universities of Padova, Zagreb, Western Sydney, and Nicosia, announced the launch of its new journal, the Journal of the Sociology of Law and Religion (JSLR). The Editorial Team of the JSLR consists of Dean Emilianides (Editor), Prof. Giuseppe Giordan (Co-editor), Dr Konstantinos Papastathis (Associate Editor) and Dr Olga Breskaya (Publications Editor).



Procedural Law Unit Empirical Study

The Procedural Law Unit published the results of an empirical study on the evaluation of the Cypriot justice system pursuant to the perceptions of Cypriot lawyers. The results were discussed in a symposium organised in memory of Alecos Markides (15.12.2021), in the presence of the Minister of Justice, MPs and the Chair of the Cyprus Bar Association. Speakers included Lord Dyson, Prof. David Rosenberg (Harvard), Prof. em. Adrian Zuckerman (Oxford), Wendy Kennett (Cardiff), and Massod Ahmed (Leicester). Directors of the Unit Anna Plevri and Nicolas Kyriakides coordinated the event.







Appointment of Christina Ioannou

Associate Dean Christina Ioannou was appointed by the Council of Ministers as a member of the Committee on Ethics and Safeguarding in Sports (February 2021), following a proposal by the Minister of Justice and Public Order. The Committee is the Cypriot national platform combating the manipulation of sports competitions.

Dean Emilianides an Alternate Member of the UAI

The Cyprus Academy of Sciences, Letters, and Arts was admitted to the International Union of Academies (December 2021), a global organisation of national academies in the fields of humanities and social sciences, with the objective to foster and fund long-term international research projects. Prof. Elena Mouzala was appointed as a national member on behalf of the Academy, and Dean Emilianides as an alternate member.









Antonis Stylianou President of the Ports Authority

Dr Antonis Stylianou was appointed by the Council of Ministers as the new President of the Cyprus Ports Authority (July 2021). The Cyprus Ports Authority is one of the largest semi-state organisations in Cyprus that owns, regulates, and provides services in Cypriot ports.



Launch of Project Reinherit

The School of Law is a partner to the consortium awarded Horizon 2020 EU funding for the project 'Redefining the Future of Cultural Heritage: Creating an Innovative Model for Sustainability' (ReInHerit). The project was launched on March 2021. The School of Law is represented by Prof. Irene Stamatoudi, Dean Emilianides, Dr Konstantinos Roussos, and Dimitrios A. Kourtis.



PhD e-Colloquium

On 11 May 2021, the School of Law organised an online PhD e-Colloquium. The e-Colloquium provided to the PhD students of the School of Law a forum to present their ongoing research, and receive constructive feedback from their peers and Faculty. Prof. Irene Stamatoudi and Dr Yiannos Katsourides chaired the sessions, whereas Vice-Rector for Faculty and Research Prof. Demetris Vrontis, and Dean Emilianides addressed the event.





Demetra Sorvatzioti Carries out Fairness Report

Demetra Sorvatzioti was assigned, in her capacity as a member of the Clooney Foundation Trial Watch Panel, to carry out a fairness report with the Columbia Law School Human Rights Clinic. According to the Report, the prosecution, the trial, and the conviction of five individuals (the Organization for Thai Federation), which advocated for a republican system of government in Thailand revealed serious violations of the freedom of expression, the fair trial right and the principle of legality.

Ioannis Kastanas Completes Post-Doc

Dr Ioannis Kastanas completed in 2021 his post-doc on the right to appeal before the Ecumenical Patriarch pursuant to the laws of the Church of Cyprus. The post-doctoral work of Dr Kastanas was carried out in the School of Law, under the supervision of Dean Emilianides, and was published as a monograph by Hippasus Publishing in January 2022.





Episode 10. Transparency as a Means to Combat Corruption: Prof. Antonis Manitakis discussed the normative and practical aspects of the fight against corruption with Auditor-General of Cyprus Odysseas Michaelides, Governor of the Hellenic National Transparency Authority Angelos Binis, Prof. Kalliopi Spanou (Athens), Prof. Nikolaos Bitzilekis (AUTH), and Dr Giorgos Tsaousis. Dean Emilianides addressed the event.

Episode 11. Dilemmas and Responsibilities of Doctors during the Pandemic: Prof. Manitakis discussed the duties, responsibilities, and challenges that doctors and paramedics face during the pandemic, with Prof. Athina Kotzabasi (AUTH), Prof. Nikolaos Bitzilekis (AUTH), Dr Christos Petrou, and Dr Nikos Koumoutzis. The event was coorganised with the Laboratory for the Research of Medical Law and Bioethics of AUTH, and was addressed by Dean of AUTH's School of Law Prof. Elisavet Symeonidou-Kastanidou.

Episode 12. Sports Justice and Disciplinary Offences in Football: Prof. Manitakis discussed the intersection between public law, State interventionism, and horizontal regulation in sports justice, with Prof. Evgenia Prevedourou (AUTH), former President of Super League Minas Lyssandrou, and Vassos Georgiou.

Episode 13. The European Pact on Migration and Asylum: Giorgos Tsaousis discussed the new European framework for migration and asylum and the contribution of Mediterranean EU member states, with the Greek Minister on Migration and Asylum Notis Mitarachi, and HoD Papastylianos.

Episode 14. Legal Regulation and the Funding of Political Parties: Giorgos Charalambous discussed the legal and political aspects of the financing of political parties with Dr Thanasis Xiros, and Dr Chistophoros Christophorou. Interventions were made by HoD Theophanous, Prof. Vasiliki Georgiadou (Panteion), Dr Yiannos Katsourides, and Dean Emilianides. The President of the House of Representatives Adamos Adamou addressed the event.


Special Episode. 1821-2021: 200 Years of Hellenic Constitutionalism: In the special episode marking the 200th anniversary since the beginning of the Greek War of Independence, HoD Papastylianos discussed the Independence War and its significance as the matrix of modern Greek constitutionalism, with Prof. Evanthis Hatzivasileiou (Athens), Prof. Spyros Vlachopoulos (Athens), and Prof. Panagiotis Mantzoufas (AUTH).

Episode 15. Labour Relations in Greece after the Adoption of the New Law on Employment: HoD Papastylianos discussed the regulatory framework on workforce and labour relations recently adopted in Greece, with Prof. Dimitrios Zerdelis (AUTH), Dr Georgios Theodosis (DUTH), Dr Dimitrios Goulas, (DUTH), and Expert Advisor to the Greek Minister of Labour and Social Affairs Athanasios Tsiouras. Dr Konstantinos Dimarellis made an intervention. The event was addressed by Prof. Manitakis.

Episode 16. Justice in Search of Expedience: Prof. Manitakis discussed the need to establish a productive, expedient, and rule-of-law oriented judicial system, with Vice-President of the Hellenic Council of State Dr Michalis Pikramenos (AUTH), Public Prosecutor Lampros Tsogkas, President of the Thessaloniki Bar Association Dr Efstathios Koutsochinas, and HoD Papastylianos.

Episode 17. Domestic Violence: Current Issues in Greece and Cyprus: Prof. Manitakis discussed the multi-level legal and practical challenges that victims of domestic abuse face, with Assistant Public Prosecutor Sappho Katsanaki, Police Lieutenant (A), Dr Nikolaos Livos (Athens), and Dr Vagia Polyzoidou.

Episode 18. The Legal Challenges of Disruptive Technologies: Prof. Manitakis discussed the challenges posed by the rise of disruptive technologies vis-à-vis law, regulations, and fundamental rights with Prof. Lilian Mitrou (Aegean), Dr Konstantinos Fouskas (University of Macedonia), Prof. Panagiotis Mantzoufas (AUTH), HoD Papastylianos, and Dr Dimitrios Koukiadis.



The School of Law launched a new series of online research seminars, offering junior faculty of the School the opportunity to present their ongoing research and receive constructive feedback. The series was chaired by Dr Andreas Kirlappos, and was co-organised with the CCEIA.

Seminar 1. Transitional Justice in Post-War Societies: Greece after the End of the Second World War: Dimitrios A. Kourtis presented his research on transitional justice in the framework of the post-1945 Greek attempts to deal with the past.


Seminar 2. Exercises in British Influence through Cultural Forces: The Case of the British Council in Cyprus in the 1950s: Dr Maria Hadjiathanasiou presented her research on cultural politics and the British Council in Cyprus during the 1950s, which seeks to establish how cultural politics and propaganda affected Colonial Cyprus.

Seminar 3. The Exceptional Case of Responsibility of Société Anonyme's Shareholders: Dr Konstantinos Dimarellis presented his research on piercing the corporate veil and attributing responsibility directly to the shareholders of a société anonyme under Greek Law.

Seminar 4. Anxiety and Resilience at Sea: The Republic of Cyprus as a Maritime Power: Petros Petrikkos presented his research, which evaluates the narrative pursuant to which maritime or EEZ threats to Cyprus are also a threat to other countries with vested interests in the region.

Seminar 5. The American 'Rocket Docket' as a Possible Solution for Cyprus: Nikolas Kyriakides presented his research arguing for the adoption of the American system of 'rocket docket' within the framework of Cyprus' comprehensive attempt to reform its civil justice system.

Seminar 6. The Remedy of Appeal before the Ecumenical Patriarch in the Church of Cyprus: Dr Ioannis Kastanas presented his research on the exercise of the right to appeal (Εκκλητόν) before the Ecumenical Patriarch in the Church of Cyprus, which was part of his post-doc carried out under the supervision of the School.

Μετά από περίπου ένα χρόνο εφαρμογής του ν. 4640/2019, έχουν ήδη αναδειχθεί σημαντικά δογματικά, ερμηνευτικά και πρακτικά ζητήματα, τα οποία προκύπτουν κυρίως από τη σύνδεση της διαμεσολάβησης με την πολιτική δίκη. Το παρόν συλλογικό έργο φιλοδοξεί να συμβάλλει στην ερμηνεία και εφαρμογή των ως άνω ρυθμίσεων υπό το φως και το δόγμα του δικονομικού δικαίου στην κατεύθυνση της αναζήτησης ερμηνευτικών λύσεων επιστημονικά βάσιμων και πρακτικά εφαρμόσιμων, ενώ δεν λείπουν και προτάσεις προς το νομοθέτη.
