



# INTRODUCTION BY THE DEAN, PROF. ACHILLES C. EMILIANIDES



When I joined the University of Nicosia – in what now seems like a lifetime ago, although only 15 years have passed-the future seemed uncertain. Until fairly recently Cypriot lawyers studied exclusively outside of Cyprus, predominantly in the United Kingdom and Greece. The first Cypriot University Law Department was only accredited in 2007: this was the Department of Law of the University of Nicosia, a private university, which soon became the first University to offer a fully-fledged law degree in Cyprus, and to have its graduates admitted to the Bar. However, the law degree we offered in 2007 was an English law degree only. Things have since changed significantly.

Whereas we keep offering a comprehensive English law LLB, the content of which we periodically revise in a substantial manner, we have established since 2010 a pioneering Cypriot law LLB, which has been widely considered as the leading Cypriot law programme in the island. Not only that, but we have been offering, for over a decade, a Greek Law LLB, which has been modelled on the programmes offered by Greek universities, thereby offering Greek students the opportunity to study Greek law in Cyprus.

This unique coexistence of separate curricula of common law (English law), continental law (Greek law), and mixed legal system (Cypriot law) is presumably without any precedent internationally. This distinctive feature of the University of Nicosia enables students to study in a comparative environment, and academics to engage in depth with distinct legal systems. I have personally taught, over the years, courses of English law, Greek law, and Cypriot law, and so have other colleagues. We are a comparative-driven environment and we are proud of this.

In addition to our LLB, the establishment of the School of Law, which hosts the Department of Law, and the Department of Politics and Governance, has allowed us to introduce new cutting-edge programmes: LLM and PhD in Law, Master and PhD in Public Administration, BA and PhD in International Relations and European Studies, MA in International Relations and Eastern Mediterranean Studies, all Master programmes also offered in Distance Learning mode, joint MA degrees with the Aristotle University of Thessaloniki in Criminal Law and Addictions, and with the Hellenic Open University in Law of the Economy, Joint PhD with the famous University of Padova and other important universities.

I have served as Head of the Department of Law between 2010 and 2016, and as Dean of the School of Law since 2016 when it was founded. I have now been re-elected for a new term ending in April 2026. I am blessed to have lived through the growth of a small Department to a large School, which aspires to grow even more, to introduce pioneering programmes, and to engage in innovative research. The University of Nicosia has grown as a whole, from a small local university to a University that is consistently included by the Times Higher Education in the list of the best universities in the world. We have our faculty, staff, and students to thank for this.

This is the fifth edition of our Annual Review, and it aims to provide you with a glimpse of activities other than standard teaching and learning ones. As always, the content of this Annual Review refers to the previous calendar year: in this case 2022.

## HIGHLIGHTS

## 2022 Graduation Ceremony

The School of Law held its Graduation Ceremony on 27.6.22. The President of the House of Representatives Annita Demetriou addressed the Ceremony, and congratulated the University for its commitment to the continuous upgrade of Higher Education in Cyprus, and for its research activity. In his speech, the President of the Nicosia Bar Association Michalis Vorkas stated to the graduates that they have secured a law degree from an academic institution of a very high standing, whose graduates honour the courts with their high level of competence and knowledge. In his own address, Rector Philippos Pouyioutas focused on the remarkable international rankings of the University, and the challenges that universities face, calling upon the graduates to contribute to a better, sustainable, and peaceful future, which shall be greener, more digitalised, more inclusive, and more just and fair. Associate Dean Christina Ioannou focused on the challenges faced in the era of social media, and called upon all graduates to filter information, and to seek the intentions, the acts, and the soul of other people, prior to judging. The University of Nicosia honoured, during the Ceremony, the former Executive Vice-President of Administration Emilios Solomou for his outstanding contribution to the University, and to education in general. The top graduates of the class of 2022, Myrto Kourouni (LLB), and Nicolaos Hatzitrakosias (MPA), also addressed the Ceremony, which concluded with the validation of degrees by the Senior Vice-Rector Constantinos Phellas, and Associate Dean Ioannou.



## Dean Emilianides Elected to the Conciliation and Good Offices Commission

Dean Emilianides was elected as a member of the Conciliation and Good Offices Commission by the General Conference of the United Nations Educational Scientific and Cultural Organization (UNESCO) during its 41st session. The Commission was established in 1970 pursuant to the Protocol instituting a Conciliation and Good Offices Commission to be responsible for seeking a settlement of any disputes which may arise between States Parties to the Convention against Discrimination in Education. Pursuant to the Protocol, the Commission seeks the amicable settlement of disputes between States Parties to the Convention. It consists of eleven members who should be persons of high moral standing and acknowledged impartiality, with recognized competence in the field of education and judicial experience or legal experience, particularly of an international character. Members of the Commission are elected for a term of six years. This is only the second time that a Cypriot has been elected as member of the Commission.

## Amongst 501-600 leading universities in Social Sciences

The University of Nicosia has been ranked amongst the leading 501-600 universities in the world, pursuant to the annual Times Higher Education (THE) World University Rankings by Subject 2023. The Times Higher Education World University Rankings (WUR) have been the largest and most multilevel rankings in the world for five decades. Dean Emilianides noted: «This new distinction of the University of Nicosia corresponds to the collective work of all faculty and staff of the University, in co-operation with our students. The field of Social Sciences falls predominantly in the School of Humanities and Social Sciences which deserves the praise for this significant distinction. We are honoured to have contributed, on our part, as School of Law. The University of Nicosia has been successful, in only a few years since it was founded, to be included in the list of leading universities internationally, both in teaching and research, thereby contributing to Cyprus' efforts to become a regional centre of studies in tertiary education».

Commenting on the results of the new rankings the Dean of the School of Humanities and Social Sciences Klimis Mastorides stated: «The recent results of international rankings confirm the remarkable quality of the persistent work of the human resources of the University of Nicosia. For our School, the impressive evaluations in the field of Social Sciences and Psychology follow a difficult time period and reward the relentless efforts of our colleagues to offer high quality scientific research and maintain a steady strategic orientation towards academic excellence. I have to also highlight the role and decisive contribution of our colleagues from the School of Law of the University towards the overall rankings in the field of Social Sciences».

It should be noted that these rankings are the latest in a series of distinctions for the University of Nicosia from Times Higher Education, highlighted by its ranking within the top 501-600 universities of the world in World University Rankings.

### CRABA 2021/2022

The leading cyprological Journal The Cyprus Review, which is published by the School of Law, awarded the Cyprus Review Annual Book Awards (CRABA) for both 2021, and 2022. The ceremony for books published in 2020 was held on 14.4.22 (CRABA 2021). Academician Paschalis Kitromilidis, who received the 2021 Lifetime Achievement Award, was the central speaker. Awards were conferred to Constantinos Adamides (Stanley Kyriakides Award), Maria Koumarianou (Peter Loizos Award), Nasia Hadjigeorgiou and Nicolas Ioannides (Constantinos Emilianides Award), whereas Maria Michaelides and Anna Neophytou received honourable mentions. A Lifetime Achievement Award was also conferred post-mortem to influential politician and author Rina Katselli who passed away in May 2021. The Ceremony for books published in 2021 was held on 28.11.22 (CRABA 2022). Noted international lawyer Kypros Chrysostomides received the Lifetime Achievement Award. Awards were also given to Kostis Kokkinoftas (Stanley Kyriakides Award), Nicos Satsias (Peter Loizos Award), Natasa Mavronicola (Constantinos Emilianides Award), Constantina Constantinou (Junior Researcher Award), and Kyprianos Louis (Honourable Mention).



## Re-Election of the Leadership of the School

Dean Emilianides and Associate Dean Ioannou have been re-elected as Dean and Associate Dean of the School, respectively. Their new term will last until 31.3.2026.





## **Event in Honour of Peter Pafitis**

The School of Law held an event, on 9.11.22, to honour Peter Pafitis for his contribution to the establishment and development of the Department of Law. Pafitis served the Department for a total of 23 years, from 1996 until his retirement in 2019. Dean Emilianides, Senior Vice-Rector Phellas, Associate Dean Ioannou, Emilios Solomou, Demetra Sorvatzioti, Costas Stratilatis, and Odysseas Christou spoke about Pafitis' unique qualities as an instructor, an academic, a colleague. Dean Emilianides bestowed Pafitis an honour plaque on behalf of the School, in acknowledgment of his hard work, his collegiality, his teaching abilities, and his overall contribution.



## **Faculty Developments**

Dimitrios Koukiades was promoted to the rank of Assistant Professor, whereas Irene Stamatoudi and Konstantinos Dimarellis were both granted tenure. Three new adjunct faculty were hired: Kleopas Stylianou, Anastasia Papamichael, and Christina Lederer. Ioannis Kastanas has been appointed as Research Associate. Styliana Petrou has been employed as the new School Secretary.



## Citizens Award 2022 to Nicolas Kyriakides

Co-director of the Procedural Law Unit of the School Nicolas Kyriakides received the European Parliament's European Citizen's Prize 2022. The award ceremony took place at the EU House in Nicosia. Kyriakides received the Prize for his work with NGO "Oxygono", and its affiliate projects, the "Cyprus Forum" and "Nomoplatform", an electronic legislative watchdog aiming to increase transparency. Kyriakides and all recipients of the prize in other EU member states were also honoured in Brussels during an event at the European Parliament.



## Round Table Special Issue

Dean Emilianides and Associate Dean Ioannou co-edited a special issue on "Cyprus and the Commonwealth" in the Round Table: The Commonwealth Journal of International Affairs, published by Taylor & Francis. This was the first time in the more than 100 years of the Round Table that a special issue on Cyprus was published. The issue included five articles, written by Dean Emilianides and Associate Dean Ioannou, Michalis Kontos, Diana Markides, Andreas Karyos, and Marinos Papaioakeim. Dimitris Kourtis contributed to the editing of the issue. A launch event was held on 16.5.22 at the University of



Nicosia with the participation of Permanent Secretary of the Ministry of Foreign Affairs of the Republic of Cyprus Kornelios Korneliou, former High Commissioner of Cyprus to the UK Euripides Evriviades, Editor-in-Chief of the Round Table Venkat lyer, Senior Vice-Rector Phellas, and Emilios Solomou.

### Launch of BSEMR

The School of Law, the AUTH Laboratory for Black Sea and Mediterranean Studies, and the Black Sea and Eastern Mediterranean Academic Network (BSEMAN) co-organised, on 10.6.22, a launch event of the Black Sea and Eastern Mediterranean Review (BSEMR). The event pertained to energy, geopolitics, security, and development in a changing world order. BSEMR will be published by both the School of Law of the University of Nicosia and AUTH. Michalis Kontos is leading the initiative on behalf of the School of Law, whereas Yiannos Katsourides and Andreas Karyos participate in the editorial committee. The first issue of BSEMR will be published in early 2023.



## **Approval of Project Sust-HEIn**

The School of Law is a partner to the consortium awarded Erasmus+ funding for the project "Fostering whole institution approach to sustainability in Higher Education through systems thinking" (Sust-HEIn). The project is expected to launch in January 2023. The School of Law is represented by Odysseas Christou as Principal Investigator and Evi Eftychiou as Senior Researcher. The team will lead the creation of theoretical models of sustainability in higher education.

## Agreement with AUTH

Dean of the Law School of Aristotle University of Thessaloniki Panayiotis Glavinis and Dean Emilianides concluded an agreement of scientific co-operation between the two Schools. The agreement aims to the development of further relations of scientific co-operation in the fields of education, research, and training, through exchange of faculty members, the development of joint activities and programmes, the support of the respective research and educational activities, and the design and implementation of joint research programmes and projects. Prof. Manitakis is responsible on behalf of the School for the implementation of the agreement.



## Legal Seminars with Sakkoulas Publications

The School of Law and Sakkoulas Publications signed an agreement for the provision of distance learning legal seminars to professional lawyers (advocates, notaries, legal consultants etc.), as well as to other professionals interested to be trained on legal topics. The collaboration began with a 12-hour training seminar, between 14.5.22 and 4.6.22, with Prof. Haroula Apalagaki (AUTH) as instructor. The topic of the seminar was the new law



of bankruptcy. The second training seminar was taught by Anna Plevri between 3.12.22 and 20.12.22. The topic was mediation and civil procedure. Prof. Manitakis and HoD Papastylianos have the overall scientific co-ordination of the training seminars.

## MoU with IAPR

The School of Law concluded an MoU for educational and research co-operation with the Independent Authority for Public Revenue (IAPR). The objective of the MoU is to develop the necessary conditions for the development of a framework for educational and research co-operation and exchange of knowledge in cutting-edge areas and fields of joint interest. The co-operation focuses on the Master and Doctoral Programmes in Public Administration. Giorgos Kentas is responsible on behalf of the School for the implementation of the agreement.







## MoU with the Cyprus Ports Authority

The School of Law and the Cyprus Ports Authority concluded an MoU on 24.11.2022. The MoU was signed by the President of the Ports Authority Antonis Stylianou and Rector Pouyioutas, in the presence of representatives of the Ports Authority under its Director-General, Senior Vice-Rector Phellas, and the Dean and Associate Dean of the School of Law. The MoU aims to establish and promote multilevel co-operation between the Cyprus Ports Authority and the University of Nicosia with the objective of further enhancing the scientific, educational and other co-operation amongst the parties. The University of Nicosia appointed Christina loannou as representative for the implementation of the MoU on behalf of the University of Nicosia.



## PhD Colloquium

The School of Law organised a PhD e-Colloquium on 8.4.22, 12.4.22, and 15.4.22. The aim of the e-Colloquium was to provide the PhD students of the School with a forum to publicly present their ongoing research, and receive constructive feedback from faculty and their peers. The Colloquium was organised by Prof. Stamatoudi and Yiannos Katsourides.

## Be a Lawyer for a Day

As part of its ongoing effort for training and educating high-school students, the School of Law organised training seminars in Nicosia (28.5.22, 15.10.22) and Athens (6.7.22), under the general title "Be a Lawyer for a Day". Participants were given the opportunity to take part in an empirical moot trial lab, headed by Grigoris Michaelides and Andreas Christou, so as to become better acquainted with law.



## **OUR EVENTS**

## **Contemporary Questions of Justice**

In 2022, the School of Law continued its seminar series under the general title "Contemporary Questions of Justice", with Prof. Antonis Manitakis acting as the general co-ordinator of the series.

### Episode 19. The Bioethics of Vaccines and of Biomedical Research, on 10.2.22

Examined the complex issue of evaluating vaccines from the point of view of bioethics, with HoD Papastylianos, Takis Vidalis (National Bioethics Committee), Evangelos Protopapadakis (EKPA), and Fereniki Panagopoulou (Panteion).

### Episode 20. The Consequences of the Digital Technology in the Labour Market, on 28.2.22

Discussed the consequences of the digital revolution on the traditional labour market structures, with HoD Papastylianos, Dimitrios Koukiades, former EU Commissioner Anna Diamantopoulou, and Christos Ioannou (SEV).

## Episode 21. The War in Ukraine: The Breach of National Sovereignty and Economic Sanctions, on 6.5.22

Reviewed the fundamental principles of international law in the light of the Russian invasion in Ukraine and the unprecedented economic sanctions imposed, with the former Vice-President of the Greek Government Prof. Evangelos Venizelos (AUTH), Deputy Minister of Education and Religions of Greece Angelos Syrigos (Panteion), and former Cypriot Minister of Justice and Public Order Kypros Chrysostomides.



## **Femicide**

On 25.1.22 the School organised a seminar on the legal and criminological aspects of femicide, with Vagia Polyzoidou, Stergios Mitas, Stavroulla Soukara, Charalambos Papacharalambous (UCY), and HoD Papastylianos. The event was moderated by Prof. Manitakis.



## **Drug Treatment Courts**

On 11.2.22 the School of Law and the AUTH Faculty of Law coorganised a conference on Drug Treatment Courts. The objective was to explain to participants the philosophy and practice of such courts and why their successful implementation reduces both crime and addiction. The conference was addressed by the Minister of Justice and Public Order Stephie Dracos. The speakers were Ontario Supreme Court Justice Kofi Barnes, Jennifer Graham, Robin Cuff, Lorne Sabsay. The conference was moderated by Demetra Sorvatzioti.



## Student Participation in Parliamentary Discussion

On 16.2.22 students Marilyn Stavrou and Nicoletta Dionysiou, accompanied by Nicolas Kyriakides, participated in the round table discussion on parliamentary transparency, held in the House of Representatives. The discussion was held on the occasion of the official visit of the Speaker of the UK House of Commons in Cyprus.



## **Religious Conflicts**

On 5.4.22 the Cyprus Center of European and International Affairs (CCEIA) organised a seminar by Constantina Karathanou on national and religious conflicts. The seminar was moderated by Michalis Kontos.



## The Establishment of the Republic of Cyprus

On 11.4.22 the School of Law, in co-operation with the Center of European Constitutional Law – Tsatsos Foundation, Papazisis Publications, and observatory "Syntagma Watch" co-organised an event relating to the negotiations leading to the establishment of the Republic of Cyprus, on the occasion of the publication of the relevant book of Dean Emilianides. Prof. Xenofon Kontiades (Panteion) addressed the event, whereas the speakers were Prof. Evanthis Hatzivasiliou (EKPA), HoD Papastylianos, Polys Polyviou, and the author. The event was moderated by Associate Dean Ioannou.



## **Combating Racism**

On 13.4.22 the School of Law, the Diplomatic Academy, and the Embassy of Israel in Cyprus co-organised a lecture by Leon Saltiel on the international protection of human rights and combating racism through the UN. Constantinos Adamides addressed the event, which was moderated by Dimitrios Kourtis.

## **Paxmoot Competition**

For the second consecutive year, a team of students participated in the Pax Moot Competition, a moot focusing on private international law. This team was constituted by students Romina Gharibi, Stefani Charalambous, and Andria Eleftheriou, and was coached by student Myrto Kourouni, under the overall supervision of Konstantinos Rokas (3-6.5.2022). The students made a noteworthy effort. In terms of ranking, the team ranked sixth on the written memoranda. In the oral rounds they won two out of the four rounds. The participation of the team in the oral rounds has been funded by two law firms based in Athens, Lambadarios Law Firm and Potamitis Vekris Law Firm, and by the European Commission.

### **MIC Simulation**

A four-member delegation of students from the Department of Law participated in the Thracing on MIC: Model International Crises, a conference simulating the functioning of international organisations in the light of crisis scenarios developed during the work of the committees. The conference was organised by the Faculty of Law of the Democritus University of Thrace (Komotini). Myrto Kourouni participated in the conference as Chair of the Committee of the Council of the European Union and authored the central theme of the committee, Dimitris Pavlidis acted as Minister of Foreign Affairs of Austria, Anais Boli as a Judge of China (receiving the distinction of Best Judge), and Thanasis Sapounas as a member of the Crisis Group.



## Commonwealth Youth Exchange Programme

On 6.5.22 the School of Law, in co-operation with RCS Cyprus, offered lunch and presented the work of the University to approximately 20 students from Commonwealth countries, as part of the Commonwealth Youth Exchange Programme. Students were hosted by Emilios Solomou and Associate Dean Ioannou.



## **Dependent Labour Relations**

On 9.5.22 the School of Law and the Nicosia Bar Association co-organised a lecture on dependent labour relations in the Cypriot legal order on the occasion of the publication of the relevant book of Nicos Panayiotou. Panayiotou discussed the criterion of dependency, and its application on shareholders of private companies.







### **Book Presentation on the 1931 Insurrection**

On 9.5.22 the CCEIA organised a presentation of the book by Spyros Sakellaropoulos and Manolis Houmerianos on the position of the Communist Party of Cyprus during the 1931 insurrection. The book was presented by Yiannos Katsourides and Giorgos Charalambous. Prof. Theophanous addressed the event.

## Seeking the Missing Persons

On 23.5.22 the School of Law and Hippasus Publications co-organised a presentation for the book Avαζητώντας τα Ίχνη. The President of the Kyrenia Bar Association Nicolas Constantinides, journalist Sener Levent, and Costas Santamas addressed the event. The book was presented by Giorgos Kentas, journalist Christos Michalaros, Anastasia Papamichael, and the author Maria Karefyllidou-loannou. The event was moderated by Sofia Iordanidou (OUC).



### The War in Ukraine



# NEWS FROM OUR **AFFILIATED ENTITIES**

The Cyprus Center for European and International Affairs (CCEIA, Director: Prof. Andreas Theophanous) continued to publish its Policy Paper Series, as well as its Eastern Mediterranean Policy Note Series, and the electronic bimonthly newsletter InDepth. Events it (co-)organised are included in another section of this Review.

The Diplomatic Academy (DA, Director: Dr. Constantinos Adamides) launched the third edition of the EMSI Eastern Mediterranean Affairs (EMA) magazine (May 22), and completed the third season of the Diplomatic Academy – The Conversation podcast, while launching the fourth season (October 22). The DA carried on with its signature seminar series Dialogue with a Diplomat, hosting speakers such as the Ambassador of Poland to the Republic of Cyprus (8.11.22). It also organised a closed online seminar on China with the Embassy of Japan (30.4.22), and a hybrid event (in-person and online) on the Russian invasion of Ukraine and the implications for the Eastern Mediterranean, in partnership with Geopolitical Cyprus (19.5.22). Moreover, the DA launched its updated curriculum (September 22), which focuses on priorities that deepen the bond between embassies, the Ministries of Foreign Affairs and Defence, and the School of Law. These priorities include a conference on security and defence at the University of Nicosia, in partnership with the UK Department of Defence (29.11.22).

### **Journals**

### The Cyprus Review

For The Cyprus Review, 2022 was a year focused on invigorating and enhancing the Journal's book review section. This is something that had been set as an objective and pursued very thoroughly in the past five years, and we now feel that the mechanisms that we put in place have proved very successful. As the Editor-in-Chief of the Journal Associate Dean Ioannou states in her Fall 2022 Editorial: "Throughout the last five years we worked very hard to promote Cyprological research, by pursuing a very vigorous book review process. Our quest is to send for review every Cyprological book published in a certain year, so as to support this kind of research and encourage it further." The two issues published in 2022 included in fact a total of 39 book reviews. Moreover, the Journal's CRABA ceremonies, for which there is a distinct section in this Annual Review, have by now become wellestablished as a way to honour researchers and authors in different disciplines and promote their published work even further. Apart from the range of articles, Volume 34 included a special section on 'The State and Organised Social Groups in the Republic of Cyprus', edited by Giorgos Charalambous. In 2022 the Journal also issued an open Call for Papers on 'Performing Arts in Cyprus: Embodied Identities', which aims to attract submissions dealing with the trends in contemporary dance, theatre, and performance

### **Public Administration Review**

The second issue of the journal Eπιθεώρηση Δημόσιας Διοίκησης was published in July 2022. It contains nine scientific articles which discuss topical issues in the field of public administration in Greece and Cyprus. The approach of the articles is interdisciplinary and they use various methodological tools, in order to contribute to the development of knowledge.









Το παρόν σύγγραμμα συνιστά ένα πρωτογενές και μοναδικό τεκμήριο συνταγματικής και πολιτικής ιστορίας, διπλωματίας και διαπραγμάτευσης, που φιλοδοξεί να καλύψει ένα σημαντικό βιβλιογραφικό κενό, αναλύοντας ολοκληρωμένα το έργο της Μεικτής Συνταγματικής Επιτροπής. 
