The long-term economic crisis combined with the COVID-19 pandemic has led internationally to sharply rising unemployment, especially among young people (DECD, 2020), who face increased occupational uncertainty and become particularly vulnerable to looking for, finding and keeping a job (Mann, Denis and Percy, 2020). In addition, rapidly evolving changes due to the digital and "green" transition seem to create even greater challenges for career decision-making and planning. This issue is linked to limited access to career guidance and information services, which leads to stereotypical choices, distant from real conditions and trends in the labour market, and a low understanding of available educational and professional opportunities and career paths (Mann et al, 2020).

OECD, during the last couple of years, studies in depth the issue of career readiness of young people and the available national data, determining correlation indicators of participation in career counselling activities and services with improved employment outcomes, with the aim of mobilizing counsellors and competent agencies to provide better services for the benefit of young people (Covacevich et al., 2021a . Covacevich et al., 2021b).

At the Conference, international distinguished speakers will highlight the current concerns, challenges and opportunities aimed at bridging the gap between education and employment through a contemporary perspective and the need for timely development of professional readiness and lifelong career management skills in young people, for a new human capital with professional readiness.

Maria Siopacha Director, Career Success Centre, UNIC BSc. MSc. PhD

Maria Siopacha (Director, Career Success Centre, UNIC): BSc studies in Mathematics, MSc and PhD in Financial Mathematics. She studied in Greece (where she comes from), UK and Vienna, Austria. She started her banking career in Athens, before she was promoted and joined the Treasury Department. After working for a German bank in Market Risk Management, she joined for four years the Raiffeisen Bank International in Vienna, where she was developing the Internal Market Risk Model. After that, she joined the UBS AG headquarters in Zurich, Switzerland, in 2011, as a Director and spent a couple of years in model development of statistical economic capital models. She was promoted to Head Model Confirmation & Governance within the statistical risk aggregation methodology team becoming responsible for confirming the output figures of the Pillar 2 economic capital models and monitoring that model performance and model output is fit-for-purpose so that the statistical models can be used for risk measurement/equity attribution/risk appetite framework. From January 2018 to June 2018 she was appointed as the Local Supervisor of the Risk Methodology team in Krakow, Poland. In July 2019 she joined the University of Nicosia as the Director of the Career Success Centre.
