INTRODUCTION BY THE DEAN, PROF. ACHILLES C. EMILIANIDES



This is the sixth edition of our Annual Review. It aims to provide you with a general idea of our activities other than standard teaching and learning ones. As in previous years, the content of this Annual Review refers to the previous calendar year: in this case 2023.

The Annual Review further includes activities of the two Departments comprising the School (the Department of Law, and the Department of Politics and Governance), the affiliate entities of the School (such as the Center for European and International Affairs - CCEIA, the Diplomatic Academy - DA, the Procedural Law Unit, and the Law and Literature Lab), and the journals published by the School (our flagship *The Cyprus Review*, the *Public Administration Review*, and the *Black Sea and Eastern Mediterranean Review*).

These past years have been challenging for the region and the world. Economic recession, increasing unemployment rates, climate and health concerns, and military operations have caused global turmoil and significant distress to all, including, unavoidably, our own students, faculty and staff. Challenges to traditional ideals of academic freedom have further been exacerbated by changing societal views on the role of education.

We live in an era of technological innovation, where Artificial Intelligence is rapidly changing the landscape of education and employment as we speak. Ronald Dworkin, one of the leading figures of legal philosophy, passed away ten years ago, but his words seem of urgency: *"We have allowed academic freedom to seem pale and abstract and even fraudulent. But we must now remember how easy it has proved elsewhere for that freedom to be lost and how hard it is to regain once lost. We do carry a great responsibility, and it is time we carried it once again with pride."*

The School of Law has been steadily growing. Our flagship programme remains the LLB, which is characterised by the unique coexistence of separate curricula of common law (English law), continental law (Greek law), and mixed legal system (Cypriot law).

This distinctive feature of the University of Nicosia enables students to study in a comparative environment, and academics to engage in depth with distinct legal systems. In addition to our LLB, the establishment of the School of Law has allowed us to introduce new cutting-edge programmes: LLM and PhD in Law, Master and PhD in Public Administration, BA and PhD in International Relations and European Studies, MA in International Relations and Eastern Mediterranean Studies, all Master programmes also offered in Distance Learning mode, joint MA degrees with the Aristotle University of Thessaloniki in Criminal Law and Addictions, and with the Hellenic Open University in Law of the Economy, joint PhD with the famous University of Padova and other important universities.

The University of Nicosia has grown as a whole, from a small local institution of higher education to an international University. This is thanks to our faculty, staff and students, and their unwavering dedication to this institution.

HIGHLIGHTS

Graduation Ceremony 2023 | 26.6.2023

The Commissioner for Transparency Haris Boyiatzis was the keynote speaker of the 2023 Graduation Ceremony of the School of Law. The Commissioner indicated that he had noted, during his tenure as a judge, the high level of education the students of the University had received, and stressed that the graduates have all the necessary skills and knowledge and it is now up to them to apply them. In his own address, Rector Pouyioutas pointed out the competitive advantages of the University and focused on its significant success in international rankings. He called upon the graduates to make a difference in the lives of other humans and to support the rule of law. Dean Emilianides called the graduates to apply the skills they have acquired and to widen their horizons and knowledge, so as to become leaders in their fields. This year's top graduates Stylianos Petasi (graduate of the LLB) and Irene Hatzisavva (graduate of the MPA), also addressed the Ceremony.



Awards of Excellence 2023 | 27.6.2023

The School of Law rewarded its graduates' academic excellence in a special ceremony. The LLB top graduate Stylianos Petasi received a monetary award offered by Andreas Christou in memory of his mother Styliani, the four volumes of the Archive of the former President of the Republic Tassos Papadopoulos offered by the Centre of Studies Tassos Papadopoulos, as well as six publications offered by advocate Polys Polyviou. The School of Law further honoured students who graduated summa cum laude; books were offered by Hippasus Publications and The Cyprus Review. Re-Election of the Leadership of the Departments

Andreas Theophanous and Constantinos Adamides have been re-elected as Head and Associate Head respectively of the Department of Politics and Governance, whereas Christos Papastylianos and Irene Stamatoudi have been re-elected as Head and Associate Head respectively of the Department of Law. Their renewed term will last until 31.3.2026

Faculty Developments

CRABA 2023 | 31.10.2023

The ceremony of the Cyprus Review Annual Book Awards (CRABA) 2023, for books published within 2022, conferred the Lifetime Achievement Award to advocate Polys Polyviou for his lengthy and important contribution to Cypriot public and private law.

On presenting the Award, the Editor-in-Chief of the Review, Ass. Dean Ioannou, referred to Polyviou's published work, noting that he has authored more than 40 books on various legal topics. The President of the Nicosia Bar Association Michalis Vorkas referred to the significance of Polyviou's contribution to advocacy, and to his legacy for Cypriot lawyers. In his address, Polyviou thanked The Cyprus Review and stressed that, in addition to advocates and judges, monographs and textbooks are paramount for the evolution of legal science. CRABA 2023 further conferred the following awards: In the category of History and Political Sciences, Nicos Moudouros received the Stanley Kyriakides award for his book titled: «Διεκδικώντας την Πατρίδα. Η Τουρκοκυπριακή Αντιπολίτευση την Περίοδο 1964-2004» (Psifides).

In the same category, the Junior Researcher Award was conferred to Beatrice Pestarino for her book: "Kypriou Politeia: The Political and Administrative Systems of the Classical Cypriot City-Kingdom" (Brill). In the field of Social Sciences, the Peter Loizos Award was conferred to Maria Mathaiou and Argyro Xenofontos for their book: «Τα Παραμύθια της Κύπρου» (Centre of Scientific Research). In the same category, Nicoletta Demetriou received an Honourable Mention for her book titled: «Ο Κύπριος Βιολάρης. Η Προφορική Ιστορία μιας Επαγγελματικής Τάξης τον 20° Αιώνα» (Psifides). In the category of Law, Maria Kyprianou received the Junior Researcher Award for her book titled: «Η Ρύθμιση της Πορνείας στην Κύπρο» (Nomiki Vivliothiki). The awards in the three categories were respectively presented by Emiliou Solomou, Senior Vice-Rector Phellas, and Dean Emilianides.



Amongst 501-600 Leading Universities in Social Sciences

The University of Nicosia was evaluated by the Times Higher Education World University Rankings amongst the 501-600 universities in the world for the subject of Social Sciences. Commenting on the results, the Dean of the School of Humanities and Social Sciences Prof. Klimis Mastoridis noted that these reflect the outstanding commitment and dedication of the human resources of the University.

On his part, Dean Emilianides noted that this is a recognition of the efforts of academic faculty, administrative staff and students, and the university's commitment to academic excellence. Overall, the University was ranked this year by the Times as #1 in Cyprus and Greece, alongside the University of Cyprus, the University of Crete, and the National and Kapodistrian University of Athens, and among the top 501-600 universities globally. It was also ranked as #1 in Cyprus, alongside the University of Cyprus, among the Top 60 in the EU and among the top 101-150 in the world, by 2023 THE Young University Rankings (universities that are 50 years old or younger).



The Period of Co-Existence 1960-1963

| 1-2.12.2023

The School of Law, in collaboration with the Cypriot Society of Historical Studies (KEIS) and the Department of History and Archaeology of the University of Cyprus, co-organised an International Conference titled "The Period of Co-Existence of Greek and Turks in Cyprus (1960-1963)".

The Conference was held in memory of the late historian Costas Kyrris, and was the largest ever on the period 1960-1963, as 35 speakers presented specialised contributions on the era. The Conference was addressed by the Deputy Government Spokesman Yiannis Antoniou, Dean Emilianides, President of KEIS Emilios Solomou, and the Dean of the School of Philosophy of the University of Cyprus Petros Papapolyviou.

Academics Dimitrios Michaelides and Efrosyni Rizopoulou-Igoumenidou were declared as honorary members of KEIS. The following faculty of the School of Law presented papers in the Conference: Dean Emilianides, Andreas Theophanous, Christos Papastylianos, Costas Stratilatis, Emilios Solomou, Giorgos Kentas, Nicolas Kyriakides, Andreas Karyos, and Maria Hatziathanasiou.



The Saripolos Lectures | 31.1.2023 & 8.11.2023

The School of Law and the Larnaca Bar Association co-organised the “4th Lecture in Memory of Nikolaos Saripolos” at the House of Arts and Letters in Larnaca. The Mayor of Larnaca Andreas Vyras, the President of the Larnaca Bar Association Christakis Mouskos, and Dean Emilianides, addressed the event. The main speaker was Professor of Public Law at the University of Oxford Pavlos Eleftheriadis, who spoke on “The Constitution as Supreme Law”. Prof. Eleftheriadis analysed the idea of the Constitution as a legal concept closely intertwined with democracy. The event was moderated by Nicolas Kyriakides, with Theognosia Kouspi as a discussant.

The School of Law and the Larnaca Bar Association co-organised the “5th Lecture in Memory of Nikolaos Saripolos” at the Nikolaideion House in Larnaca. The President of the Larnaca Bar Association Dimitris Kallenos and Dean Emilianides addressed the event. The main speaker was Professor of Constitutional Law at the University of Athens Spyros Vlachopoulos, who spoke on “Nikolaos J. Saripolos. The Significance of his Work and Personality in the Modern Era”. The event was moderated by Yiolanda Zachariou, with Stella Mala as a discussant.



Harmonisation of European Labour Law | 17.3.2023

The School of Law and the Association of Labour and Social Insurance Law (EDEKA) co-organised a Conference on the harmonisation of European labour law in the legal systems of Greece and Cyprus. The Conference was dedicated to the memory of the late former Minister of Labour and Social Insurance Zeta Emilianides.

The new Minister of Labour and Social Insurance Yiannis Panayiotou, in his first significant public appearance since undertaking his duties, praised the outstanding service of his predecessor, and highlighted the importance of Cyprus utilising EU policies in labour matters. Rector Pouyioutas, Senior Vice Rector Phellas, the President of EDEKA, Professor Emeritus Konstantinos Papadimitriou, Director General of OEB Michalis Antoniou, Secretary General of SEK Andreas Matsas, Secretary General of PEO Sotiroulla Charalambous, and the Vice-President of the Nicosia Bar Association Nikolaos Koursaris, all addressed the Conference.

Professor Emeritus of AUTH Ioannis Koukiadis delivered the keynote speech, whereas advocate Polys Polyviou further delivered an introductory speech. The Conference included studies on specialised aspects of labour law in a manner facilitating comparative research. Constantinides.

There was further reference to the Presidents of the Kyrenia Bar. The Conference was addressed by the President of the Supreme Constitutional Court Antonis Liatsos, the Mayor of Kyrenia Rita Elissaoui Komodiki, the President of the Cyprus Bar Association Michalis Vorkas, and Associate Dean Ioannou.

The Court of the 21st Century | 15.12.2023

The Procedural Law Unit of the School of Law organised its 3rd Annual Symposium, with the general topic "The Court of the 21st Century. Staff and Equipment".

The Symposium was supported by the Cyprus Bar Association, and there were addresses by the Chair of the Parliamentary Legal Committee Nicos Tornaritis, the President of the Cyprus Bar Association Michalis Vorkas, the Law Commissioner Louiza Christodoulidou-Zannetou, and Dean Emilianides. The Symposium specifically addressed the structural reforms and the procedure for the evaluation of judges, and presented the findings of a poll on the quality of justice in Cyprus. The moderator of the Symposium was Nicolas Kyriakides, who also had the overall supervision of the Symposium together with Anna Plevri.

Religious Property | 20.11.2023

The School of Law and the Society for Ecclesiastical and Canonical Law co-organised a Conference titled "Religious Property in the Churches of Cyprus and Greece. A Comparative Approach".

The Conference was dedicated to the memory of the late Archbishop Chrysostomos II. Archbishop Georgios opened the Conference, congratulated the organisers, and spoke on the care showed by his predecessor for the protection of religious property. 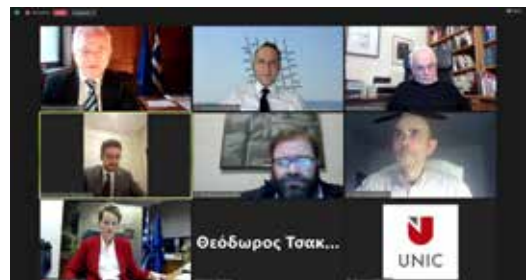

The project will promote an institutional model to support HEIn’s strategic planning in effectively responding to evolving needs and conditions to deliver systemic, institution-wide integration of sustainability.



Hydrocarbons in the South-Eastern Mediterranean | 9.2.2023

The School of Law and the School of Law of AUTH co-organised an online event entitled “The Latest Developments in the Hydrocarbon Sector in the South-Eastern Mediterranean”. The Vice Rector for Research and Lifelong Learning of AUTH Prof. Stratos Stylianidis, and the Consul of Cyprus in Thessaloniki Konstantinos Polykarpou, addressed the event. A discussion took place, with the participation of the Secretary General for Energy and Mineral Resources at the Ministry for the Environment and Energy Alexandra Sdoukou, the Dean of the Faculty of Law of AUTH Prof. Panayiotis Glavinis, Dean Emilianides, and Prof. Manidakis. The speakers evaluated the efforts of Greece and Cyprus for energy autonomy through the research and exploitation of hydrocarbons, and evaluated the consequences of the war in Ukraine for the energy sector.

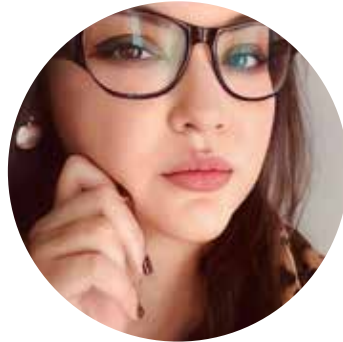

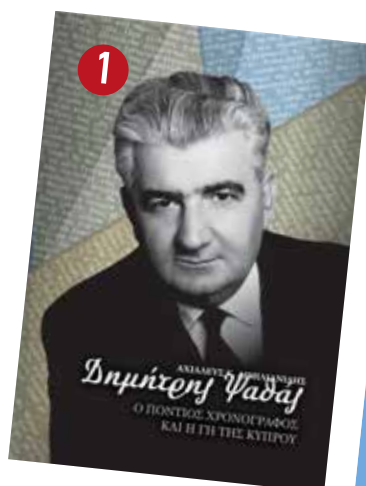
Kriton Dionysiou has been elected to the position of Secretary of the Committee on International and European Law of the Cyprus Bar Association.

Αιμιλιανίδης, Ο Πόντιος Χρονογράφος και η Γη της Κύπρου, Λευκωσία: Hippasus, 2023, σσ. 336.** Από τον Φεβρουάριο του 1951, όταν ο Ψαθάς επισκέφθηκε την Κύπρο ως απεσταλμένος της εφημερίδας Τα Νέα, μέχρι και τον θάνατό του, η Κύπρος τον απασχολούσε ανελλιπώς. Δεν σταματούσε να επαναλαμβάνει ότι το Κυπριακό ήταν το σημαντικότερο εθνικό θέμα. Σε αρκετές του πτυχές το Κυπριακό συνιστούσε για τον Ψαθά την παράλληλη ιστορία του Πόντου. Δύο κομμάτια του ελληνισμού που αναζήτησαν μάταια την εθνική τους δικαίωση, χωρίς να τη βρουν, και τα οποία αμφότερα καταστράφηκαν από τα κομματικά πάθη, τις προσωπικές φιλοδοξίες και την τουρκική σκληρότητα.
2. **Ανδρέας Θεοφάνους, Από τη Δεσμευμένη Ανεξαρτησία του 1960 στις Προκλήσεις του Σήμερα, Λευκωσία: Hippasus, 2023, σσ. 352.** Μετά το 1974 δεν έχει υπάρξει λύση του Κυπριακού ως αποτέλεσμα του τουρκικού μαξιμαλισμού και όχι του μακροχρόνιου αγώνα, που στην πραγματικότητα ουδέποτε διεξήχθη. Η Κυπριακή Δημοκρατία καθώς και ο Κυπριακός Ελληνισμός αντιμετωπίζουν υπαρκτά ζητήματα. Ως εκ τούτου προκύπτει η επιτακτική αναγκαιότητα για μια στρατηγική επιβίωσης η οποία απαραίτητα θα πρέπει να περιλαμβάνει και ένα αφήγημα. Η Κύπρος πρέπει να καταστεί κράτος πρότυπο στην Ανατολική Μεσόγειο και την ευρύτερη περιοχή. Μια τέτοια εξέλιξη θα ενισχύσει ένα πλέγμα συμφερόντων τα οποία θα περιστρέφονται γύρω από την Κυπριακή Δημοκρατία.

Να αναστοχαστούμε και να ανανοηματοδοτήσουμε τις θεμελιώδεις έννοιες της Πολιτειολογίας: του κράτους, του φιλελεύθερου και του απολυταρχικού, της κυριαρχίας (κρατικής και λαϊκής), της διάκρισης των εξουσιών, του κράτους δικαίου και του κοινωνικού, της δημοκρατίας και του κοινοβουλευτικού συστήματος. Να διερωτηθούμε, κυρίως, για το μέλλον του κράτους και της δημοκρατίας.
5. **Αντώνης Μανιτάκης, Η Κυριαρχία στο Θολό Τοπίο της Παγκόσμιας Διακυβέρνησης, Αθήνα: Αλεξάνδρεια, 2023, σσ. 192.** Αντικρούοντας τις απαισιόδοξες προβλέψεις για υποχώρηση και αποδυνάμωση του κράτους και έκλειψη της κυριαρχίας του, ο συγγραφέας του παρόντος δοκιμίου υποστηρίζει ότι και τα δύο είναι παρόντα και ισχυρά, μεταμορφωμένα, όμως, με νέους ρόλους και νέες λειτουργίες, προσαρμοσμένες στις απαιτήσεις ενός κόσμου που συνεχώς αλλάζει, ραγδαία και απρόβλεπτα. Στη μεταβατική αυτή περίοδο, το κράτος μετασχηματίζεται σε τοπικό ή περιφερειακό παράγοντα μιας απρόσωπης, σόρατης, πολυδαίδαλης παγκόσμιας δικτύωσης διεθνών -τεταμένων και ενίοτε εμπόλεμων- σχέσεων κυριαρχίας κρατών, διεθνών οργανισμών και αγορών. Το μέλλον του μπορεί μεν να φαντάζει, ακόμη, αβέβαιο, όλα τα σημάδια όμως δείχνουν ότι, προς το παρόν, καλά κρατεί, ζει και βασιλεύει και τον κόσμο κυριεύει, όντας, ταυτόχρονα, θύμα και συντελεστής της παγκοσμιοποίησης. 7. **Άννα Πλεύρη, Μελέτες Αστικού Δικονομικού Δικαίου Διαιτησίας & Διαμεσολάβησης (2008-2022), τόμ. 1, Αθήνα-Θεσσαλονίκη: Σάκκουλα, 2023, σσ. 1447.** Ο προκείμενος τόμος συγκεντρώνει σχεδόν 15ετές έργο της συγγραφέως και περιλαμβάνει μελέτες, γνωμοδοτήσεις, παρατηρήσεις και σχόλια σε δικαστικές αποφάσεις, σε σημαντικά δογματικά και πρακτικά ζητήματα από το πεδίο του αστικού δικονομικού δικαίου, του δικαίου της διαιτησίας και του δικαίου της διαμεσολάβησης, άπαντα δημοσιευμένα σε νομικά περιοδικά ή ως συμβολές σε πρακτικά συνεδρίων και συλλογικά έργα. Η ύλη του τόμου αφορά σε εργασίες στην ελληνική και στην αγγλική γλώσσα από το έτος 2008 έως και το θέρους του έτους 2022, όλες στη μορφή με την οποία δημοσιεύθηκαν αρχικά.

Στη σύγχρονη ψηφιακή εποχή, του επαναστατικού απρόσωπου λόγου του διαδικτύου, τώρα περισσότερο από ποτέ, γινόμαστε όλοι μας συχνά μάρτυρες, ενός διαδικτυακού κατακλυσμιαίου λόγου με παράνομο περιεχόμενο τόσο στις διάφορες υπηρεσίες διαδικτύου όσο και στα μέσα κοινωνικής δικτύωσης.
