PRE-UNIVERSITY ENGLISH

Students may need to take pre-university English courses based on their score in the English Placement Test. These courses carry additional teaching hours per week and fewer ECTS and tuition is based on the teaching hours.

TRANSFER OF CREDITS/ECTS

Course credits/ECTS completed at other recognised institutions may be transferrable to the University. The Evaluation fee for this is €60. Candidates will need to submit official Transcripts and course descriptions in English.

PAYMENT OF TUITION AND FEES

According to the migration regulations of Cyprus, Non-EU students are required to be enrolled on a full-time basis (30 ECTS per semester, 60 ECTS annually) and to pay at least the first semester's tuition and any applicable fees in advance. The required advance payment is outlined in the Financial Information attachment provided together with the student's Letter of Acceptance and must be settled in full, unless otherwise specified by the University. For subsequent semesters, students may be eligible to follow a payment plan in instalments, subject to an initial registration deposit of €1,500. Tuition and other fees are calculated and charged at the beginning of each semester (Fall and Spring).

A late payment charge of 4% per year may be imposed on all overdue amounts until their full settlement. Students with outstanding financial obligations to the University will not be permitted to receive examination results, grades, transcripts, degree certificates or other documents, or enrol for the following semester until their accounts are settled.

PAYMENT OPTIONS

All payments should be made in Euro (€) through one of the following payment options. **Students are advised to always state their student ID number.**

1. Online through the University website

This option is available for new applicants who wish to pay their application fee or tuition deposit online. Online payments can be made via JCC Gateway, Paypal, Flywire and Bitpay. Applicants should visit the University's website (www.unic.ac.cy) and go to Applicant login or www.unic.ac.cy/apply

2. Online Payment through UNIC Portal

(You can access the Portal provided that you have obtained a student ID and have received your credentials)

- Log in to the UNIC Portal: <https://portal.unic.ac.cy/signin>
- Click on the "€ Finance" section
- Select your preferred payment method (JCC, Flywire, or BTCPay)
- Enter the amount you wish to pay and click "Proceed"
- Follow the on-screen instructions to complete your payment

3. Online at JCCSmart

Visit the internet site www.jccsmart.com

- From the "Categories", select "EDUCATION"
- Click on "University of Nicosia"
- Click on "Pay"
- Enter your JCCSmart e-mail and password
- Enter your University Student ID (the ID must begin with U or A) and click on "Next"
- Enter the amount you wish to pay

FINANCIAL AID

The University wishes to support Non-EU students who experience financial hardship, and will examine each case, with its relevant documentation, individually.

SCHOLARSHIPS

Partial scholarships based on academic merit and athletic achievements are available.

Based on Previous Academic Performance

Non-EU students, in their first year at the University, are eligible for a scholarship on the basis of the grades of their High School Leaving Certificate, depending on the country in which this qualification was issued. Scholarships are given as a percentage reduction on tuition and are valid for one academic year.

In order to be eligible for this type of scholarship, students must:

- submit their High School Leaving Certificate and/or Bachelor's Degree upon application,
- pay the whole semester's tuition and fees in advance, and
- be registered on a full-time basis (30 ECTS per semester)

More information about this type of scholarship can be obtained from the Admissions Department.

Based on Academic Performance at the University

Two regular semesters after the student first registers and every semester thereafter, scholarships will be awarded according to the student's academic performance at the University, as follows:

Cumulative GPA	Scholarship
4.00	50%
3.75-3.99	20%
3.50-3.74	10%

In order to be eligible for this type of scholarship, students must have:

- full-time status (30 ECTS per semester)
- completed a minimum of 60 ECTS at the University, and
- been registered in the previous semester

Notes:

1. Scholarships are not applicable to Postgraduate (Master or Doctoral), Medical School, School of Veterinary Medicine and E-Learning/Distance Learning (Online) Programmes.
2. Students who are eligible for more than one type of scholarship will be awarded the scholarship constituting the highest amount.

- Bachelor's degree and transcripts (Postgraduate students)
- Master's degree and transcripts (Doctoral students)
- Research proposal (Doctoral students)
- Two letters of recommendation/reference (Postgraduate students)
- Personal statement (Postgraduate students)
- CV (Postgraduate students)

VISA PROCEDURE

Non-EU Students are required to apply for a student visa in order to enter Cyprus. A series of documents must be assembled (e.g. police character certificate, medical reports, etc.) and must be attested by the appropriate authorities in the student's country. As the attestation process differs between countries, please contact the Admissions Department for further advice.

Student visa completed applications must be submitted to the University by the appropriate deadline of each intake.
